



Copyright

The Copyright Act of 1976 is the primary law that governs copyright in the United States. It extends copyright protection to all works, whether published or unpublished, once they are fixed in a tangible form. The copyright owner is the only person who has the privilege of reproducing their copyrighted material free of charge.

For all uses of copyrighted material, permission must be obtained from the copyright owner. It is always illegal, as well as unethical, to reproduce copyrighted choral octavos, solo works & hymn accompaniments. This article deals specifically with the issue of reproducing liturgical texts and congregational music, whether in printed worship aids, projected on a screen, or streamed online.

The rules are simple and straightforward. Liturgical texts may be printed in a worship aid if copyright and reprint information is properly noted. Congregational music may be reprinted by purchasing a reprint permission license from the appropriate copyright licensing agent. Licenses are typically categorized as annual, single-use, event, or practice-track licenses. Once the appropriate reprint permission license has been purchased, the parish/institution has the right to reproduce the melody-line and/or words to congregational music in a worship aid for use in a religious service. Unless otherwise provided by the copyright owner (Taizé, for example), only the melody may be reproduced. Cantor verses, harmony, chord designations, or accompaniment parts may not be reproduced under regular circumstances. The copyright holder or their agent provides the exact information needed to acknowledge use of their materials in a worship aid.

The majority of the music used in parishes throughout the Diocese of Cleveland is owned by 3 publishing companies: GIA Publications (now includes World Library Publications), OCP, and Christian Copyright Licensing International, (<https://ccli.com/us/en>). GIA and OCP participate in [OneLicense.net](https://www.onelicense.net) for reprint permission.

Both licensing agents have searchable databases of the song titles and composers they represent. License Holders have access to thousands of congregational hymns, songs, and service music from today's liturgical music publishers for use in worship aids, service bulletins, and projections. Additionally, all copyrighted music that is livestreamed must have copyright "podcast" use permission. License rates are equitably and fairly based upon the average weekly attendance of the congregation.

Parishes that utilize licenses for reprinting music in worship aids, bulletins, projections, or streaming, in addition to purchasing the license, are obligated to the following:

1. Properly identify the citation of copyrighted works.
2. Report usage of music per the license rules.

Reporting usage allows composers and authors to receive their fair share of royalty payments. We have a moral obligation to support the authors of the music we use.

There is no Diocesan copyright license for parish use. Every parish that elects to reprint or stream music is responsible for obtaining permission by purchasing the proper license and reporting their usage per the terms of the reprint license. The Office for Worship maintains a diocesan license for diocesan celebrations coordinated by various diocesan offices.

Citing Copyrighted Works

The International Commission on English in the Liturgy (ICEL) is a mixed commission of Catholic Bishops' Conferences in countries where English is used in the celebration of the Sacred Liturgy according to the Roman Rite. The purpose of the Commission is to prepare English translations of each of the Latin liturgical books and any individual liturgical texts in accord with the directives of the Holy See and the sponsoring Conferences of Bishops.

How to Acknowledge Mass texts:

The copyright acknowledgment should include: the name of the ICEL text, the copyright symbol, year of publication, ICEL's corporate title (may be abbreviated), and the phrase “all rights reserved” (see examples below). For a complete listing of copyrighted materials [click here](#).

How to Acknowledge Music – either text alone or text and music notation:

For music covered under OneLicense, use the following format to create your unique copyright line.

*Words: John Doe, © 1988 ABC Music Co.; Music: Jane Doe, © 1990 XYZ Publications.
Reprinted with permission under ONE LICENSE #A-000000. All rights reserved.*

If words and music are by the same composer, you may combine these lines. Music covered under CCLI follows a similar format.

Copyright information must be typed into your worship aid, bulletin, slideshow, etc. The usual location for the citation, including the reprint permission license number, is immediately below the music notation or hymn text, but other locations within the body of the worship aid or bulletin are permitted, such as at the beginning or the end of the worship aid.

The copyright symbol (©) can be created by typing “(c)” or using the shortcut Option + G on your keyboard. You must include your ONE LICENSE license number with any reprint or projection. Simply replace the “000000” with your unique license number.
